In June, we will also celebrate the unveiling of the Vel Phillips statue on the State Capitol grounds. The State Bar and the Wisconsin Law Foundation, lead sponsors for the statue, contributed \$25,000 on behalf of the 25,000 members. Notably, the statue is the first on the Capitol Square to recognize a person of color. Phillips is considered one of Wisconsin’s most prominent and influential attorneys. She made significant contributions as a civil rights leader, lawyer, and judge. The statue celebrates diversity in state leadership and offers generations of Capitol visitors an opportunity to learn about her impact.

Lastly, I want to thank our outgoing board members for their dedication to improving Wisconsin’s legal system better. I hope you will continue to be involved as a volunteer, either with the State Bar or in your own communities.




### Leadership Development Committee



The Wisconsin Institute for Law & Liberty's complaint against the State Bar's Diversity Clerkship Program, beginning in December, and its amended complaint challenging the Leadership Program, the Leadership Development Summit, and the Ready.Set.Practice. Mentoring Program, topped the list of State Bar of Wisconsin media stories in FY 23-24.

The DCP challenge netted 285 stories in local, regional, and national news, garnering 18 percent of the State Bar's total news coverage.

### State Bar Media Mentions by Month Top Publications

The most mentions of the State Bar came from the *Wisconsin Law Journal*, followed by Targeted News Service, *Wausau Pilot & Review*, and WisPolitics. These mentions do not count the "Know Your Legal Rights" stories.

**Bolstering the G. Lane Ware Endowment Fund**



Thanks to numerous individual donations, and two generous matching challenge grants, the fundraising campaign to bolster the Law Foundation’s G. Lane Ware Leadership Development Fund raised \$44,669 on an original goal of \$16,818. As of the end of May, the campaign raised \$44,669 to add to the Ware endowment. This means the Foundation will be able to increase its support of leadership development programming by nearly 50% this next year.

Donations were spurred by Atty. Kevin Lyons, a Wisconsin Law Foundation board member, who pledged to match every donation, up to \$20,000. In addition, Ruder Ware, in honor of its longtime former president Lane Ware (also a State Bar past president) provided a matching grant to all donations made by individual firm members. With the match, over \$6,000 was contributed by members of the firm. The firm has a long history of leadership and support of both the Wisconsin Law Foundation and State Bar of Wisconsin.

The State Bar of Wisconsin program focuses on identifying up and coming leaders in the legal profession, and providing the skills, resources, and connections needed to step into leadership roles in their communities and local bars, as well as the State Bar.
